I am initiating this correspondence to you in my capacity as the attorney for the Town of Westville, LaPorte County, Indiana ("Westville"), in regards to CVS Health's recent acquisition and anticipated closure of the Fagen Pharmacy branch located in Westville. The Westville Town Council recently learned of the anticipated closure of this branch and is very concerned that it could have a substantial negative impact on the residents of Westville and surrounding unincorporated areas in LaPorte County. So you are aware, with the closure of this branch, Westville will be left without both grocery store or pharmacy. As a result, residents of Westville and the unincorporated areas including the elderly will likely now be forced to travel some distance to Michigan City to shop for groceries and medical supplies.

As a result of the above concerns, the Westville Town Council requested that I send this letter to request a meeting with representatives from CVS to discuss the closure of this branch. Representatives from Westville are willing to meet in a location that is most convenient for you. At your earliest convenience, I would appreciate if you could provide me with several dates and times when you are available to meet




